## COMPETITION RULES:

1. Competitors must be registered and financial at the date of the close of the competition with the appropriate State/Regional Committee.
2. Competitors must dance in their own age group and level only.
3. The age of the competitor will be taken as at the date of the competition.
4. The organiser reserves the right to refuse an entry, substitute a judge and/or alter the programme at their discretion.
5. **All dancers must compete at own risk. NO responsibility will be taken for any accidents, injuries or lost property. This includes ALL persons present at the competition.**
6. **8 Dance Rule applies to this competition.**
7. The Judges' decision is final, and no correspondence will be entered into.
8. Videoing will be at the discretion of the judge.
9. The ABHDI direct that dancers use dressing rooms to change costumes and dress fully, appropriately and respectably (i.e. not exposing their bras or crop tops) when in public at competitions. The ABHDI recommend that teachers and competition organisers advise the dancers to dress appropriately and modestly.
10. During the competition the comportment and behaviour of the competitors may come under the jurisdiction of the Judges, not only whilst dancing, but also when entering or leaving the platform and whilst waiting for the dance to start. Any unseemly behaviour on the part of a competitor or any misdemeanour likely to upset the decorum of the proceedings may be penalised by the Judges and could lead to disqualification. A full report of any such conduct on the part of a competitor must be submitted by the Judge to the Organiser. In serious cases, the Judge should also provide a report of any such conduct on the part of the competitor to the Organiser and to the SOBHD.
11. **NO ENTRY FEES WILL BE REFUNDED EXCEPT WHERE AN EVENT IS CANCELLED, or unless written request is received within 14 days after the event, such request to be accompanied by a medical certificate.**
12. Be sure that your entries are correct. Cheques or money orders must accompany completed entries. STAMPS WILL NOT BE ACCEPTED. Direct Debit to SASCHDI available.
13. Protest: As per SOBHD Constitution - Any complaint made by an individual against the organization or adjudication of an event must be made in writing giving the complainant's full name and address and shall be lodged with the organiser, if possible on the day of the event and certainly not later than forty-eight (48) hours after the event. Such complaint must be accompanied by a deposit, the amount to be set by the Board. The deposit shall be returned should the complaint be upheld. If within 7 days of lodging such complaint the complainant has received no satisfaction from the organiser, then the complainant may refer the matter to the Honourable Secretary of the Board.
